No further orders will be shipped until restitution has been made.
- Delivery: All full truckload, short truckload, and route truckloads will be charged based on the correct zone pricing. All bulk freight shipments delivered by Daddy Pete's Transport will be charged per loaded mile from the Daddy Pete facility. A fuel surcharge will be applied to all shipments when applicable. Daddy Pete's products are delivered via Daddy Pete's Transport unless Purchaser makes other shipping arrangements; or unless Daddy Pete's Plant Pleaser determines that LTL freight is more economical. Purchaser may also pick up orders from the Daddy Pete facility. Delivery dates are approximate and subject to delay due to events beyond the reasonable control of Daddy Pete's Plant Pleaser or Daddy Pete's Transport.
- Taxes: A copy of valid reseller certificate that provides wholesale tax number (resale number) must be submitted prior to shipment.
- Confidentiality: Wholesale prices and price lists of the Company's products are confidential and for the use of the Purchaser only. Publishing or revealing the wholesale pricing of the Company's product line outside of the business of the Purchaser is strictly forbidden without prior written consent from the Company.
- Modification: Daddy Pete's Plant Pleaser reserves the right to modify any of the terms and conditions contained in this agreement.
